LEGAL SERVICES AND DISABILITY: PUBLIC RIGHTS IN CALIFORNIA

Presentation from various organizations from the greater Los Angeles area regarding the history, policy and legal realities, and resources available to the public where Disability and self-determination are involved.

- Jordan Kough, Executive Director, Disability Rights Legal Center (DRLC) - The DRLC champions the civil rights of people with disabilities as well as those affected by cancer and other serious illnesses. Through bringing cases to court and winning victories DRLC helps to protect and expand the rights of people and eliminate discrimination and other legal barriers.
- 2. Ben Conway, Litigation Counsel, Civil Rights Practice Group, Disability Rights California (DRC) - The DRC is the largest disability rights group in the nation. Established through federal law to protect and advocate for the rights of people with disabilities, they are the protection and advocacy agency for California. The Civil Rights Practice Group specializes in disability discrimination law, including the Americans with Disabilities Act and Fair Housing Amendments Act, and litigates complex discrimination cases statewide.
- Dr. Meredith Goetz, Founder, Special Education Law Clinic Dr. Goetz founded the first Special Education Law Clinic in California in 1996 at Frank D. Lanterman Regional Center in Los Angeles. Under Dr. Goetz' supervision, law students from UCLA, UCI, USC, Pepperdine, Loyola, UC Hastings, Southwestern and Whittier Law Schools have provided legal assistance and direct representation for more than 2,000 children over the past 20 years.
