ITEM NO. (6): EXECUTIVE DIRECTOR'S REPORT

Ongoing update on items relating to Department activities, metrics, budget, planning, and/or other relevant issues. Presentation is by Ricki Rosales, Acting Executive Director, Department on Disability and/or other department staff. DOD is currently working with the Safe Inside program that gives people safe places to move inside with ongoing support and can stay inside and safe for good. The program also addresses the City's approach to street homelessness, looking at how teams engage with those individuals in order to improve outreach efforts. DOD goes out with others from the Safe Inside program to identify people who will need durable medical equipment and other disability related resources. DOD has gone out to two encampments. DOD is working with the Personnel Office to hire the position for the Assistant Executive Director and they should start on January 23rd or 30th. DOD has two staff who are departing from the office. Scott will be returning back to school and Danny is moving to LAX. DOD will be interviewing to replace those positions and other positions that are open. Lastly, DOD is getting close to finishing the budget and is preparing by scheduling meeting with the council offices in the Budget and Finance Committee and Civil Rights, Equity, Aging, and Disability.
